#### 1. The Chairman to open the meeting and receive apologies.

The Chairman opened the meeting at 7:06 pm.

Apologies were received from Cllr S Avery, N Inwood, S and I Spokes, C and J Austin.

#### 3. Reports:

## 4. Approval to consider, amend as agreed by the Council and approve the minutes of the following meeting:

It was proposed by ClIr A Brent, seconded by ClIr V Flower and agreed by all to approve the minutes of the Tuesday 16<sup>th</sup> November 2021 meeting.

#### 5. Finance

- **5.1** It was proposed by Cllr A Brent, seconded by Cllr N Orchard and agreed by all to approve the payment schedule.
- **5.2** It was proposed by Cllr A Brent, seconded by Cllr N Orchard and agreed by all to approve the bank reconciliations for November and December 2021.
- **5.3** The Clerk presented the quarterly budget update.
- **5.4** The Chair's report, budget and precept for 2022 23 was presented to the council. It was proposed by Cllr N Orchard, seconded by Cllr A Brent and agreed by all to request a precept of £6155.00.

#### 6. Funding & Grants

**6.1** It was proposed by Cllr V Flower, seconded by Cllr A Parkes and agreed by all to apply for Tidy Teignbridge funding, if successful the monies received will be used to upgrade the litter picking equipment.

#### 7. Footpaths and Highways:

**7.1** We are waiting for an update from DCC Highways on works to deal with ongoing drainage issues, following the verge planing that was carried out before Christmas.

It was noted that a number of drainage issues in the parish are originating from private land and suggestions on ways to educate landowners will be discussed at the March meeting.

- **7.2** It was agreed to contact P3 to discuss the maintenance and upgrade of Footpath 1 and (depending on the outcome of a public consultation), use CIL funds to carry out any work needed.
- **7.3** It was noted that the annual P3 survey and finance forms have been received.
- **7.4** It was proposed by Cllr A Parkes, seconded by Cllr V Flower and agreed by all to spend £1666 + VAT on 1 x Brush Cutter, 1 x Hedge Trimmer and 1 x Battery Pack. This will be paid for by CIL funds, a £500 P3 grant and £300 offered by Cllr A Dewhirst from his Locality Budget.

**11.1** The following planning applications were discussed:

21/02935/CAN - Manor House, Coffinswell

Remove lower branches of one pine and one oak as indicated in the submitted pictures There were no objections to this application.

21/02927/HOU - 2 Manor Cottages, Coffinswell

Replace rear extension with a conservatory and replacement windows

There were no objections to this application.

#### 21/02928/LBC - 2 Manor Cottages, Coffinswell

Replace rear extension with a conservatory and replacement windows

There were no objections to this application and councillors were happy for a decision to be made following heritage guidelines.

21/02836/HOU - Bartholomew Cottage, Coffinswell

Rear double-storey extension

There were no objections to this application.

#### **11.2** The following withdrawn applications were noted:

21/01408/HOU – Old Timbers, road from Westcombe Park to Princess Cottages, Coffinswell Construction of residential annexe and replacement garage; alterations to vehicular access including new timber gates; extensions and alterations to conservatory/bay to create two-storey side extension; construction of chimney and addition of canopy over front door. Application withdrawn.

Clerk to request a TDC site visit to confirm the correct procedures have been followed regarding permitted development and the garage replacement.

20/02129/FUL - Land east of Normans, Daccombe

Change of use of field to equine and erection of stable block with store.

Application withdrawn

TDC confirm that this has been passed to planning enforcement for further investigation.
